**Elliot Gibbons** recently graduated with an MA in the History of Art department at UCL. He has a BA (hons) in Fine Art from Chelsea College of Arts (UAL). Her thesis attempts to create an embodied definition of gesture in the Early Modern period in Europe, with a focus on Italy.
